

### **OEA Legislative Watch – Rob Fetters**

Every election year, we hear that this is the most important election ever. And every year this is true. Educators throughout Ohio have learned this lesson, if not before the last election, then after it. Now we all know how political our jobs are. Now we all know how school funding is determined by elected politicians at the local, state, and national levels. Now we all know the importance of voting for, working for, and contributing to pro-public education candidates.

But where to start? OEA's website, <a href="www.ohea.org">www.ohea.org</a> can help. You can become an ACE, an Advocate for Children and Education. You can volunteer on school levies, on pro-public education candidates' campaigns, make phone calls, and knock on doors. You can contribute to the Fund for Children and Public Education, our political action committee. You can also contribute \$50 to \$100 to a state candidate at no cost to you, by including this contribution on your state tax form, you earn a tax CREDIT, meaning dollar for dollar, it doesn't cost you anything but maybe a stamp. #### NEA Representative Assembly – Washington D. C. July 2 - 5, 2012

The week surrounding the Fourth of July, the National Education Association meets for its annual Representative Assembly. This year it was held in Washington, DC, as it is every four years. The RA is a chance for delegates from all over the United State to come together and make decisions on how the NEA should proceed. This year the delegation heard motivational speeches from NEA President Dennis Van Roekel, NEA Executive Director John Stocks and special guests, Vice President Joe Biden and Dr. Jill Biden. President Obama was in Ohio during the RA, but he did call President Van Roekel during one of the business meetings, and the delegation had a chance to listen in on the conversation.

Besides the speeches business was conducted as well. Delegates voted on amendments to the NEA Constitution and Bylaws, Legislative and Resolution documents. The delegates also have the right to bring new business items before the delegation. All of this is very interesting because you experience the democratic process at work. This year 89 new business items were submitted to the RA over the 4 days. Some new business items got moved to a committed to be review so that sped up the process, some were not considered based on object to consideration motions, and the rest are debated, some were modified, then approved or defeated. Congratulations Rob for all the hard work you have done and will continue to do.

The evening events were a chance to mingle with other NCOEA members as well as members from the rest of Ohio, such as Ohio Night: dinner and dancing for the Ohio delegation, The Awards Dinner to celebrate with Rob, and a combined dinner cruise with the North Western District.

The experience of the RA is a chance to be a part of what makes the NEA a strong union.
